How have you participated in East Bay Stonewall Democratic Club activities, and/or supported the Club other ways? What other LGBTQ+ organizations are you affiliated with and in what capacity? What other Democratic clubs are you affiliated with? *

I have participated in East Bay Stonewall Democratic Club endorsement process and meetings as a candidate in the special election for Assembly District 18. I am a current member of the CA State Assembly Democratic Caucus, City of Alameda Democratic Club, California Party Democratic Party Renters' Council and am proud to have been endorsed by the California Democratic Party and California Young Democrats. I am also proud to be affiliated with organizations such as Equality California, Black Women Organized for Political Action; California Black Women's Collective, Black Achievers' Alliance, Sierra Club, and Oakland Rotary who aim to promote equity and inclusion of all.

Using specific examples, please identify the causes you have advocated for and the ways you have helped advance LGBTQ+ rights or otherwise helped foster a community of inclusivity for LGBTQ+ individuals and families. *

When I was in college I served as an ethnic counselor to Puerto Rican, African American and AAPI students finding their way through Yale University, the institutional embodiment of white supremacist culture. In that role as a junior and senior, I was the person that nearly a dozen BIPOC young people came out to first, and in a few instances, sadly, last. Every young person would talk to me about the fear of letting their family down, of knowing that there were cultural and generational connections that would be hard to sustain, and most predominantly their parents' worry that they just wouldn't be able to live a full life as they defined it--married, healthy, with children, and a thriving job. Helping LGBTQ identifying youth in those early years, translated for me into building an awareness around the inequities that the LGBTQ community endures--marriage inequality, healthcare, reproductive rights, housing, and job discrimination among them.

As a School Board Member with Alameda Unified, I supported anti-hate, anti-discrimination policies and practices like creating positive all gender neutral spaces, standing up for gender identity and sexual health course content beginning in elementary school, standing up for inclusive and intersectional curriculum that speaks to the wealth our community has in its diversity of family structures, re-writing our equity policy to be inclusive of our LGBTQ community, and re-drafting our restorative justice programming to ensure we are applying a more explicit and inclusive lens around the impacts on LGBTQ students and families of our bias. Since beginning my service as an Assemblywoman, we've been focused on delivering on our promise to uplift East Bay children and working families. I'm proud to have co-authored the law to guarantee health care for all and the "It Takes A Village Act" to provide cradle-to-career community-based services to end child poverty in California. Most recently, I am proud to have co-authored legislation with my colleagues that will: Reject any out-of-state court judgment removing trans kids from their parents based on parents allowing their kids to receive gender-affirming healthcare, and such judgments are against California public policy and precludes those judgments from being enforced in California courts.

Bars compliance in California with any out-of-state subpoena seeking health or related information about people who come to California to receive gender-affirming care, if the subpoena relates to efforts to criminalize people, or remove children, based on receiving gender-affirming care.

States California's public policy that enforcing any out-of-state arrest warrant for someone based on violating another state's law against receiving gender-affirming care is the lowest law enforcement priority in California.

Have you previously supported LGBTQ+ candidates for office? If yes, did that include financial support? *

Most recently, I am proud to support, my District Director, who is a black, queer women running for Democratic Central Committee in AD18, Rowena Brown.

Jim Oddie's campaign for Alameda City Council: Literature drop, precinct walked, endorsed, contributed.

Verna Castro's campaign for Alameda Unified School District Board: Fundraised, assisted with the County Democratic Party endorsement process, sat on the campaign committee, walked precincts. Would have been the first openly gay school board member, I supported Verna despite opposition from local teachers.

Angela Normand's campaign for Alameda County Office of Education Board: Fundraised, walked precincts, worked to secure ADEM endorsement, publicly endorsed.

RobinLynn Wilson, appointed AUSD school board member for Community Learning Centers Schools--recruited, nominated, and secured School Board vote.

Brendalynn Goodall's campaign for Alameda County Democratic Central Committee: Encouraged her to run, donated, made calls on her behalf.

Imber Anakata, elected Advocacy Chair PTAC and elected founding Officer at Large for the California Democratic Party Renters' Council. Encouraged her to run, advised her on policy, worked to found the Renters' Council.

Which LGBTQ+ organizations and elected officials have formally endorsed you for this race? *

I have been honored to receive the endorsement of the Stonewall Dem Club in the past, Former Alameda City Councilmember Jim Oddie, Imber Anakata founding Officer at Large for the California Democratic Party Renters' Council.

Please describe a policy/goal that is part of your formal platform that benefits the LGBTQ+ community? *

I believe that my platform on Women's economic justice, including reproductive and health justice, will also benefit and highlights challenges faced by the LGBTQIA+ community. For too long, women's health has been undermined and undervalued in our health policy and systems. Women and families remain under-insured, forced to link their right to health security and health coverage with their work status, and we have experienced the encroachment on our rights to our bodies through legislative, court, and policy decisions in surrounding states that are already signaling to us here in California that our country will rely on our legislative leadership on these issues for the national stage.

What makes you uniquely qualified for the office and how are you different or unique from the other candidates in your race? *

My lived experiences, as an Afro-Latina, as a mother of three brown children, as a graduate of Yale University and Yale Law-- towering examples of white supremacy, and as a young girl growing up in the Bronx who was well on her way down the school to prison pipeline. It was only a chance encounter with a teacher who helped me enter into a gifted program which gave me the opportunity to live a different life. Because of that teacher, that opportunity, I was then able to attend one of the most elite educational institutions in this country-- Yale University. I had to work four jobs, received a scholarship and walked away with massive student debt, but I graduated and ended a cycle of poverty for my family forever. My best friend, who did not get the same opportunity to enter into the gifted program, ended up pregnant at age 14. A chance encounter should not determine whether our youth can explore their full potential, have a job that will help them thrive, and enable their family to live securely. Since then, I have dedicated my life, through non-profit service and working in education and for children, youth, and working families to ensure that Black, Latino, API and children experiencing poverty and discrimination could be assured that their schools had an education, health supports, mental health supports, and career technical education and pathway programs. I have three children who are Black, Latino, and API. Issues of social, racial, environmental, and economic justice are not just abstract concepts to me, but are the center of my lived experiences. I have seen firsthand how the systems in our state -- from education and the criminal justice system to health care and housing -- often fail to provide for all Californians. The pandemic has further exacerbated systemic inequalities, while exposing once again the precariousness of so many people's livelihoods. That is what motivates me, and separates me from my opponents.
