Through my mental health experience, I was able to begin my advocacy for my queer tribe. Across over a decade of social services work, I have always prioritized my Black and Queer identities in my advocacy work toward expanding mental health services and participation, working to minimize the experience of homelessness by queer foster youth, and leveraging my position on the Oakland Housing & Rent Board to expand tenant protections for queer renters in Oakland. I am currently working to expand Oakland's definition of 'protected status' for housing and evictions to include Queer individuals as a protected class.

Have you previously supported LGBTQ+ candidates for office? If yes, did that include financial \* support?

Which LGBTQ+ organizations and elected officials have formally endorsed you for this race? \*

It would be an honor to earn EBSDC's support as my first LGBTQ+ organization's endorsement.

Please describe a policy/goal that is part of your formal platform that benefits the LGTBQ+ community?

Codifying federal protections for LGBTQ+ Americans into law through legislation, and introducing legislation the expands the U.S. foreign policy platform to include advocating for queer rights and queer individuals around the globe.

What makes you uniquely qualified for the office and how are you different or unique from the \* other candidates in your race?

I bring into this race over a decade of experience in social services, with a background in psychology. My life experience as a queer black man, and my professional experience coupled with my legislative experience as Chair of the Oakland Housing & Rent Board place me in a unique position. I am able to speak with purpose and intention to issues that impact various groups, be that LGTBQ+ communities, Black, Brown, and Indigenous Communities, Aging Adults, Differently Abled communities, Foster Youth, Formerly Incarcerated individuals, and Working Class Americans just to name a few. I will serve CA12 with a perspective that is currently lacking in the U.S. House; a perspective that prioritizes the needs of the people over profit, personal gain, and party priorities when they do not center the needs of the people. I offer an alternative to the political blueprint we've been given and have continued to use for decades despite its repeated failure, or unwillingness to meet the needs of the people. That is what separates me from the other candidates in this race. As our nation evolves, so must the way we govern. This is how we continue the work of Reimagining our Democracy.
